### **EXECUTIVE REPORT ON THE ACTIVITIES OF TENNIS SENIORS AUSTRALIA**

On behalf of the executive, I am pleased to present this report on the activities of Tennis Seniors Australia (TSA) to the 2021 annual general meeting.

This year's executive (four out of six are new) took on the challenging role of managing a disunited TSA in the wake of the vote in 2019 in Brisbane against the winding up motion and the rejection of a funding motion at the 2020 AGM at Busselton that would have allowed TSA to collect an annual levy calculated on the numbers of members of divisional members.

The new executive held a meeting in Busselton with the presidents and secretaries of divisional members. The main discussion topic was relations with Tennis Australia (TA) and how to move forward given the differences between some of the divisional members regarding the future of TSA. Despite the differences, there was full support from the attendees for TSA to enter into discussions with TA with a view to forging a new relationship that would see TSA and TA working together in the role previously performed solely by TSA.

Relations with TA and the future of TSA were canvassed in last year's annual report. It goes without saying that TA is very important to seniors' tennis in Australia. However, as it stands, TA provides no funding to TSA and plays no decision-making role in the activities of TSA.<sup>1</sup>

Furthermore, a contrast in expectations with regards to the activities that TSA should be performing has emerged over the last year or so. Traditionally, TSA's role has been reasonably narrow and was confined to involvement with competitive tennis such as the teams' carnival, the Australian individual championships and the selection of teams to represent Australia in world events. However, in last year's annual report, there was mention of TSA's possible

involvement in TA's Adult Participation Strategy, which implies a wider lens including social play, plus the TSA objects allow a wider remit and include "social tennis activities" (rule 3). the view of the executive that TA's main interest lies in promoting the game more widely as designed in its participation strategy rather than the narrower focus traditionally given by TSA. Reconciling the different interests of the divisional members and with TA's interests is at the heart of reaching an agreement. TSA has much to offer in a joint arrangement. For example, it has acquired, through its divisional members, much "corporate knowledge" about the administration of competitive seniors' tennis, player rankings, teams' selections and there is the volunteer base who work in and oversee the staging of complex tennis events such as the teams' carnival and the individual championships.

The executive is currently in discussions with TA. In June 2020, the executive put forward a funding model and proposal for an in-principle harmonisation of TA and TSA. It is the executive's position that any in-principle agreement would be subject to consultation with the divisional members before any final agreement is reached. So far, reaching an in-principle agreement remains a work in progress and the next executive should not have the same set back to deal with that Covid-19 presented to the current executive.

In terms of on court action, the 2020 tennis year began strongly in January in the delightful seaside city of Busselton, Western Australia which was host to the teams' carnival and the Australian Championships. In the teams' carnival, there were 735 players making up 118 teams while 246 players competed in the Australian Championships. These player numbers were strong for the teams' event, with about 50% of the players registrations coming from interstate, and were also good for the individual event given

the location. There were also very enjoyable social events including the opening ceremony and the closing presentation dinner held at the Abbey Beach Resort. The executive would also like to pay tribute to Max Bates who was awarded TSA Hall of Fame membership and to Ros Balodis who was elevated to legend status at the presentation dinner. Congratulations go to Tennis Seniors WA for organising such a wonderful event, to all those who competed and to the winners of the various events over the two weeks of competition.

Another highlight of the Australian seniors' tennis calendar is the Oceania Regional tournament. As flagged in last year's annual report, TSA did not play a role in this year's tournament held between 5th and 9th March 2020, other than as one of its sponsors. It is around the time of Oceania that Covid-19 took hold which stopped most tournaments in their tracks and which lasted for the remainder of 2020 including the cancellation of all ITF events, all international representative teams' events and world individual championships.

Other than the above, there is little to report with regards to tennis activities in 2020, except that Brenda Foster and Mary Gordon were also named as members of the TSA Hall of Fame later in the year. A wonderful achievement and congratulations to both women.

The divisional members of TSA returned a combined membership of 3,364 calculated as at the close of their financial years as follows:

Another development during the year was the lowering of the youngest age category from +35 to +30. The executive is proposing a special resolution at this year's AGM to change the constitution to enable conformity between the TSA rules and this change. Hopefully, this will see an expansion of seniors' tennis in future years. Also, both the TSA website and the Facebook page are valuable platforms to put out information about seniors' tennis and the executive has noticed their popularity by the number of visits these sites have received during the year.

The executive held 11 meetings over the course of the year to discuss TSA business and there was virtually a full attendance at every meeting. Using zoom is proving to be an easy and cost-effective option for holding meetings.




### **HALL OF FAME 2019**
