## **Tournament Conditions**

1. This Tournament is sanctioned by Fiji Tennis Association and approved by ITF and OTF and shall be conducted in accordance with the laws of the game adopted by ITF and Fiji Tennis Association.
2. The Tournament Committee shall have the entire control of the tournament and reserves the right to make such changes and decisions considered necessary for the management of the tournament.  
  
Should any dispute arise on matters not included in the conditions, and not left specifically to the Referee, the matter shall be referred to the Tournament Director whose decision shall be final.
3. Doubles competitors are expected to enter with partners. If a partner is not nominated, the Tournament Committee will endeavor to locate one but will not guarantee to do so. Partners as allocated must be accepted.
4. Each competitor must submit an entry form accompanied with fees and their signed Player Agreement and Release Form. No player will be entered into the draw until the entry fee and signed Player Agreement and Release Form has been received. No refunds will be given after the draw has been made.
5. Singles Events 1—13; Doubles Events 14—26; Mixed Doubles 27—32 will be conducted as ‘Knock—Out’ events and shall be the best of 3 tie-break sets. For the Singles Events a rest period, not exceeding 10 minutes, may be taken at the end of the second set.
6. Should entries in any event be fewer than 6, the Tournament Committee may combine that event with the next age group or play it as a round robin event if previously indicated as a ‘Knock—Out’ Event.
7. All competitors are guaranteed two matches in the events they have entered. A Compass Draw, Consolation or Feed in Events will be conducted to provide the 2nd match for players losing their first round matches in the knock out events. Byes are not deemed ‘a match’, but Walkovers and Forfeits are deemed matches.
8. If the number of entries received in a Singles Event(s) exceeds 16 then play in those events may be necessary on Monday afternoon 12th September. In the event of this occurring the required competitors will be notified by the 9th September.
9. Regulation Tennis attire must be worn. Shoes with barred, studded or rippled soles will not be permitted.
10. Wilson tennis balls will be used exclusively for the tournament.
