MEMO TO ALL AFFILIATED CLUBS & EXECUTIVE

In accordance with the provisions of the Constitution of Tennis Seniors Queensland Inc, the **Annual General Meeting** will be held at:

Queensland Tennis Centre, 190 King Arthur Terrace, Tennyson on Wednesday 7th December 2022 at 5:00pm.

The business of the Annual General Meeting is to receive the President's Annual Report, and the audited Financial Statements, to elect the office Bearers and an Auditor for the coming current year, and to consider such other business as may be properly before the meeting. All members are welcome to attend but only nominated delegates for Affiliated Clubs are allowed to vote. **Please ensure that Secretary has been advised of your Club's nominated delegate before the meeting.** Clubs may be represented at the meeting by a nominated delegate as long as that person is a bona fide member of an Affiliated Seniors Club. The appropriate form naming the delegate must be completed by Club Secretary and forwarded to TSQ Secretary **by Wednesday 23rd November 2022**.

If an affiliated Club cannot be present at the meeting and wishes to vote, a ballot paper is enclosed to register a vote in respect of:

- The election of office bearers
- The appointment of an Auditor
- Items of Approval as listed on the Agenda.

The ballot paper must be counter-signed by the Club's President or Secretary and be in the Associations Secretary's hands prior to the commencement of the meeting.

- Nominations are called for the Management Committee, i.e. President, Vice-President, Secretary, Treasurer and Committee member. These nominations should be on the attached form and must be signed by the Nominee, Nominator and Seconder and should be in the hands of the Secretary by Monday 21st November 2022
- 2. Nomination form for Club delegate. If an affiliated Club cannot be present at the meeting, they may nominate a person to represent the Club at the Annual General meeting by completing the attached form and return to Secretary by Wednesday 23rd November 2022.
- Nominations are called for 2022 Senior of the Year Award. A list of past winners is attached together with a nomination form.

Nominations to be in the hands of the Secretary by Wednesday 23rd November 2022.

4. <u>Nominations are called for Queensland Selectors (3 Men & 3 Women).</u> We require one in each of the following age groupings and the nominees should be of an age within that grouping (where possible):

MEN 35 to 45; MEN 50 to 60; MEN 65 to 80+ WOMEN 35 to 45; WOMEN 50 to 60; WOMEN 65 to 80+

Nominations can be made on the attached form by an Affiliated Club or any current financial member.

Nominations must be in the hands of the Secretary by Wednesday 23rd November 2022.

Final Agenda and Financial reports will be forwarded to all Clubs prior to the meeting.
